To be eligible for admission to the programme, a candidate shall satisfy both the University admission requirement and the programme specific requirements as listed below:

- (a) shall comply with the [General Regulations](#);
- (b) shall hold a Master of Social Sciences in Clinical Psychology degree of this University, as appropriate; or another qualification of equivalent standard from this University or from another University or comparable institution accepted for this purpose;
- (c) for a candidate who is seeking admission on the basis of a qualification from a university or comparable institution outside Hong Kong of which the language of teaching and/or examination is not English, shall satisfy the University English language requirement applicable to higher degrees as prescribed under General Regulation G2(b)*;
- (d) shall satisfy the examiners in a qualifying examination if required; and
- (e) preferably shall have working experience in the field of Clinical Psychology, as appropriate.

An application for exemption from the above requirements shall be considered on a case by case basis.
