**Master of Dental Surgery in Prosthodontics**

Applications are invited for admission in September 2019 to read for the degree of Master of Dental Surgery in Prosthodontics (three-year full-time). To be eligible for admission to the curriculum, a candidate shall:

- (a) comply with the General Regulations and the Regulations for Taught Postgraduate Curricula;
- (b) hold the degree of Bachelor of Dental Surgery from this University, or a degree or other qualification of equivalent standard from another university or comparable institution accepted for this purpose;
- (c) for a candidate who is seeking admission on the basis of a qualification from a university or comparable institution outside Hong Kong of which the language of teaching and/or examination is not English, shall satisfy the University English language requirement applicable to higher degrees as prescribed under General Regulation G2(b); and
- (d) satisfy the examiners in a qualifying examination if required.

The closing date for applications is **12:00 noon (HKT), April 12, 2019**. [Note: Late applications may still be considered at the discretion of the Postgraduate Programme Director.]

Students will be required to purchase some clinical kits for their clinical training details of which will be provided upon offer of admission.*

*Apart from offering a small number of self-financing places in each cohort to study the MDS(Prostho) curriculum, a number of government-funded places might become available in 2019-20. Confirmation on this is being awaited. Candidates who are interested in studying the MDS in Prosthodontics are advised to apply for admissions to the curriculum as soon as possible. Candidates who fulfil the eligibility criteria (yet to be announced) for the government-funded places may be offered the opportunity to take up such quotas.*
